## TERMS AND CONDITIONS OF SALE:

1. That this puppy should be examined by your licensed veterinarian within 72 hours of receipt. If your veterinarian determines the puppy to be ill, or for any reason this puppy

is unacceptable, Buyer may return the puppy for a full refund provided it is in the same condition as at the time of purchase. If puppy is returned due to illness, a verified letter from your veterinarian is required. This includes death or illness from any health condition deemed present prior to removal from our premises.

- 2. That said dog will be given adequate and proper shade, housing, property and sufficiently fed. This dog shall not be neglected in any manner and in no way mistreated.
- 3. That said dog shall receive adequate and proper veterinary care throughout his/her lifetime and appropriate minimal vaccine and titer protocols be maintained to ensure preventative health care.
- 4. That Buyer guarantees Seller right of first refusal if this dog is to be sold or disposed of in any way. If at any time, for any reason the Buyer cannot keep the puppy, the puppy must be returned to the Seller unless approval is given by the Seller in writing for the new home. If the puppy is returned to the Seller and the puppy is resold, all profits are the Buyer's. Profits are defined as the purchase price minus any reasonable expenses, for example but not limited to updating vaccinations, heartworm testing, spay/neuter or transportation expenses.
- 5. That the Buyer shall promptly notify Seller of any address change made by Buyer.

- 6. That the Buyer agrees to the prefix "RANDHILL" at the beginning of the dog's registered name.
- 7. That Buyer agrees to notify Seller of any titles completed as determined by the AKC, CKC, GRCA and/or NAHRA.
- 8. That in order for the Seller to maintain a quality breeding program, it would be helpful for the Buyer to obtain an OFA evaluation of the dog no later than thirty (30) months of age. Buyer will furnish copies of said reports to Seller.
- 9. That this dog will not be used for purposes of vivisection and shall not be sold by or to a wholesale establishment or any chain store, catalog sales house, pet store or puppy mill.
- 10. That this puppy should not be encouraged to jump or run on hard surfaces or be subjected to hard exercise for the first eighteen months of his/her life, particularly when he/she is going through their fastest growth phase between four and seven months. All guarantees will become void if the owner allows or causes the puppy to engage in any prolonged or sustained activity that could potentially cause undue stress on developing joints. This includes activities such as jogging, Frisbee catching, biking, agility jumping, fetching tennis balls across paved surfaces, etc.

The Buyer understands that, while every care is taken to breed sound, healthy puppies free from hereditary defects, mating two dogs that are themselves clinically free of hereditary disease does not guarantee that the offspring will themselves be problem free. It is suggested that the Buyer contact their veterinarian for advice on hereditary problems found in the breed. NOTE: Surgeries for orthopedic disorders are not covered by this guarantee. Should you be advised that as a young puppy your dog has hip dysplasia, we require that you get a second opinion from Seller's recommended veterinarian specific to your area.

NO GUARANTEES OR WARRANTIES, ESPRESS OR IMPLIED, ARE GIVEN BY RANDALL HILL AS SELLER, AND ALL DOGS ARE SOLD/DELIVERED IN AN "AS IS" CONDITION EXCEPT AS EXPRESSLY AND SPECIFICALLY SET FORTH HEREIN. This puppy may be, but is not represented as show quality.

Seller warrants and agrees that he is the lawful owner of the dog, that the dog is free from all encumbrances, that he has the right to sell same and that he will warrant and defend the title of the dog from all lawful claims and demands. The Buyer has read and understands the foregoing and agrees that all parts and portions thereof constitute a binding agreement. This contract constitutes the entire agreement of the parties hereto with respect to the sale herein above mentioned.

Optional: That by mutual signing of the Non-Breeding Clause at the time of sale no offspring of the aforementioned dog will be afforded registry with the AKC, nor will any breeding information be furnished by the AKC. Copies are to be retained by both Seller and Buyer and a third copy filed with the American Kennel Club.
- D. All expenses shall be incurred by Buyer.
